I, the undersigned, state that I have thoroughly read, understand and agree to the terms and conditions of this Agreement (which may be amended from time to time, if applicable) which are stated and set forth herein and are fully incorporated in to this form. I hereby execute this Agreement for my pet, myself and my heirs, successors, representative and assigns. I further attest that if I am not the sole owner or representative of the dog subject to this application that my signature is sufficient to enter into this Agreement for and on behalf of any other owner or representative.

**Policies, Procedures, Release, and Waiver of Liability,  
Assumption of Risk and Indemnification**

By, for, and in consideration of my pet being permitted to be a client at Platinum Grooming, daycare and boutique LLC . (hereinafter referred to as "Platinum Grooming )," I hereby give the following representations and consent and agree to the policies, procedures and terms as set forth herein:

**CONSENT**

I am placing my dog as a client to Platinum Grooming, daycare and boutique LLC for the purposes of grooming and/or daycare services. I understand and am aware that all due diligence and loving care will be taken with my pet for the safety and well being of my pet, as well as the groomer, dog sitters, and other employees of Platinum Grooming, daycare and boutique LLC .

I have been advised that neglect or lack of consistent brushing of my pet's coat can be a cause for problems after grooming such as clipper or brush irritation. I also understand that if my pet doesn't remain still during grooming, wiggles, or jumps around, that accidents can happen such as nicks/scrapes from clippers or scissors. If my pet's coat is matted, I may brush my pet's coat and return at a later time for grooming. I may also request a shave and start with a fresh coat on my pet.

**PERSONAL PROPERTY**

I agree that Platinum Grooming, daycare and boutique LLC shall not be responsible or liable for any lost, stolen, or damaged personal property belonging either to my pet or myself. I also understand and agree that my pet's collar may be removed in the grooming area to prevent injury and to allow for ease in grooming.

**RIGHT TO REFUSE SERVICE**

Platinum Grooming, daycare and boutique LLC has the right to refuse service for any reason it deems. In the event that we believe a pet cannot be groomed safely without danger to the groomer, employees or other pets, Platinum Grooming, daycare and boutique LLC will utilize muzzles, collars or other grooming devices to ensure safety for all. In the event that the groomer or employees believe that there is a danger to either the pet, themselves, or other pets in our facilities, grooming services will be stopped until further discussion has been made with the owner.

**ABANDONED DOGS**

Platinum Grooming, daycare and boutique LLC should be a fun place where all pets can play, exercise and socialize safely. No pet should ever be abandoned at Platinum Grooming, daycare

and boutique LLC. I acknowledge and agree that I will pick up my pet by the time he or she is scheduled to be finished or leave the facilities, unless I have contacted Ivy League Boarding and Grooming LLC and made other arrangements.

Any pet that is left at Platinum Grooming, daycare and boutique LLC without any contact information, instructions or notification time from me, of the ability, willingness or plans to pick him/her up by myself or my personal representative or agent, will be considered abandoned upon the third day of such notification failure.

I understand that if I abandon my pet at Platinum Grooming, daycare and boutique LLC, said facility will become the owners or guardian of said pet by default. By becoming the legal owner and guardian of the pet, Platinum will then be the proper agent to act in the best interest of the pet and ensure that he or she is taken care of and what steps need to be taken to ensure the pet is cared for after abandonment. We will, at our sole discretion, determine whether to try to rehome and adopt the pet from our location. ***I FULLY UNDERSTAND AND AGREE THAT IF I ABANDON MY PET AT Platinum Grooming, daycare and boutique LLC I MAY BE UNABLE TO RETRIEVE POSSESSION OF MY PET AND WILL HAVE NO LEGAL OR OTHER RECOURSE AGAINST Platinum Grooming, daycare and boutique LLC AS PROVIDED HEREIN.***

### **PHOTOS AND VIDEO RELEASE**

I consent and agree that Platinum Grooming, daycare and boutique LLC may use any photographs, videos or snapshots of my pet, including any Platinum Grooming, daycare and boutique LLC owner, employee, officer, director and/or agent to use my pet's name and any images or likeness of my pet taken while he or she is a client of Platinum Grooming in any form or format, for use, at any time, in any media, marketing, advertising, illustration, trade or promotional materials. I consent and agree that said provision shall be binding on me and all of my successors, heirs, and legal representatives.

### **DUTY TO DISCLOSE**

I acknowledge that it is imperative and for others' safety, as well as the safety of my pet, that I disclose, and will continue to disclose on an ongoing basis, any and all medical or other conditions, including but not limited to personality concerns or behaviors that may affect, limit or prevent my pet's ability to participate in play time, grooming or otherwise attend Platinum Grooming

### **ACCEPTANCE AND ACKNOWLEDGEMENT OF DAYCARE RISK**

I FULLY UNDERSTAND THAT THERE ARE POTENTIAL RISKS INVOLVED WITH INTERACTIONS BETWEEN HUMANS AND DOGS, AS WELL AS BETWEEN OTHER DOGS, WHICH MAY RESULT IN PROPERTY DAMAGE OR BODILY INJURY, INCLUDING BUT NOT LIMITED TO, PERMANENT DISABILITY, SICKNESS OR DEATH TO HUMAN OR DOG; AND THAT THERE MAY BE OTHER RISKS NOT KNOWN TO ME NOR READILY FORSEEABLE AT THIS TIME. I HEREBY CONSENT TO AND FULLY ACCEPT AND ASSUME ALL RISKS AND RESPONSIBILITY FOR ALL RISKS, INCLUDING, WITHOUT LIMITATION, ALL LOSSES, COSTS AND DAMAGES INCURRED AS A RESULT OF MY DOG'S PARTICIPATION AT PLATINUM GROOMING, INCLUDING ANY VETERINARIAN EXPENSES INCURRED ON

BEHALF OF MY DOG. SICKNESS SHALL BE DEFINED TO INCLUDE ANY ILLNESS INCLUDING BUT NOT LIMITED TO BORDETELLA (KENNEL COUGH) OR ANY OTHER FORM OF CONTAGIOUS ILLNESS.

#### **non-disparagement clause**

*During the term of our agreement and thereafter, the client shall not make any disparaging remarks, or any remarks that could reasonably be construed as disparaging, regarding our company, its officers, employees, or representatives. In the event of a breach, liquidated damages may apply. You will be kind to all employees and not use any foul language while inside the facility, near employees or customers.*

#### **VETERINARIAN LIABILITY AND CARE**

I agree and consent that Platinum Grooming, daycare and boutique LLC, may obtain medical treatment for my dog, if, in its sole discretion it appears that, he/she is ill, injured or exhibits any other behavior that would reasonably suggest that my pet may need medical treatment and Platinum Grooming is unable to reach me or my emergency contact at the numbers I have provided above. I ACKNOWLEDGE THAT I WILL BE FULLY RESPONSIBLE FOR THE COST OF ANY SUCH MEDICAL TREATMENT, AND FOR THE COST OF ANY TRANSPORTATION FOR THE PURPOSES OF SUCH TREATMENT, PROVIDED TO MY DOG.

#### **WAIVER, RELEASE AND INDEMNIFICATION**

I HEREBY AGREE TO EXPRESSLY AND FOREVER GENERALLY WAIVE, DISCHARGE CLAIMS, INDEMNIFY, RELEASE FROM LIABILITY, SAVE, HOLD HARMLESS, AND DEFEND PLATINUM GROOMING, THEIR EMPLOYEES, OWNERS, AND/OR AGENTS, OFFICERS AND DIRECTORS AND ALL OTHERS HAVING INTEREST IN PLATINUM GROOMING FROM AND AGAINST ANY AND ALL INJURY, LIABILITY, CLAIMS, LITIGATION, ACTIONS, SUITS, COSTS, LOSSES, DAMAGES, ATTORNEY'S FEES, EXPENSES OR DEMANDS OF EVERY CHARACTER WHATSOEVER ON THE ACCOUNT OF, ARISING OUT OF, RESULTING FROM OR RELATING IN ANY WAY TO (I) ANY ACT OR OMISSION OF THE RELEASEES, INCLUDING NEGLIGENCE, AND (II) MY OR MY PET'S PARTICIPATION IN DAYCARE, OR OTHERWISE.

I HAVE READ AND FULLY UNDERSTAND THE TERMS OF THIS AGREEMENT AND POLICIES, PROCEDURES AND DOG RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK AND UNDERSTAND THAT I MAY BE GIVING UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF LIABILITY TO THE GREATEST EXTENT PERMITTED BY THE LAWS OF THE STATE OF GEORGIA AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID OR UNENFORCEABLE, THE REMAINDER OF THIS AGREEMENT SHALL REMAIN IN FULL FORCE AND EFFECT.
